# Safe Table Meetings

### Overview:

KIPSQ will conduct Safe Table meetings on various topics at several locations throughout the state. Participants will:

- Generate candid discussions on patient safety and quality issues
- Exchange information about best practices relative to patient safety

### Who Should Attend:

Who should attend: Hospitals should consider attendance by chief medical officers, chief nursing officers, patient safety professionals, patient safety officers, risk managers, and quality team. Hospitals are asked to also select 1-2 front-line staff members to attend. Safe Tables are in-person meetings – no participation is permitted by conference call.

Attendees will be presented with a case study on the topic and are encouraged to come prepared for open discussion. All information shared in the Safe Table will remain confidential inside and outside of the meeting. All participants are required to sign a privacy agreement upon arrival at the meeting.
